The 2020+ Ford PI Utility Close-To-Dash mount (7160-1337) is designed to mount on top of a Gamber-Johnson 2020+ FORD PI Utility console box 7160-1334 or 7160-1335. Modifying the Close-To-Dash mount or other Gamber-Johnson products will void the warranty on the Gamber-Johnson products.

## Attaching the mount to the Console box:

- 1. Remove the (2) 1/4-20 x .50" long socket head machine screws that hold the top plate on the right side of the console box.
- 2. Place the mount into position and attach with the  $1/4-20 \times .88$ " long socket button head machine screws and lock washers found in the hardware bag. These screws mount in the location the 1/2" long screws were removed in step 1.
- 3. The top side of the mount is held down with the 1/4-20 x 1.00" long carriage bolts, flat washers, lock washers, and hex nuts found in the hardware bag.
- 4. In lieu of the carriage bolts, a motion attachment like the Mongoose (7160-0220) or the 6" locking slide arm (7160-0500) can be used to mount a keyboard and hold the Close-To-Dash mount down to the top plate.
